Overview

One region; connected locally and competing globally.

The South East Queensland (SEQ) City Deal was signed on 21 March 2022 and establishes a partnership between the Australian Government, Queensland Government and Council of Mayors (SEQ).

The three tiers of government are working collaboratively and contributing resources to deliver 29 commitments to generate long-lasting benefits for the community of SEQ. This Implementation Plan provides detail on the delivery of each of the 29 commitments.

Delivery of the 29 commitments will build on existing investments by all levels of government and the private sector to generate thousands of local jobs, boost digital and transport connectivity, enhance liveability and support one of the fastest growing regions in the country. Projects will support the region to develop and deliver high-quality connectivity and community infrastructure. These projects will support the region's booming population and complement broader work to deliver a successful Brisbane 2032 Olympic and Paralympic Games.

The Australian Government, Queensland Government and Council of Mayors (SEQ) acknowledge the region's traditional owners and celebrate Aboriginal and Torres Strait Islander peoples' ongoing and valuable contribution to SEQ's economic, social, and cultural life. All levels of government are working in partnership with Aboriginal peoples and Torres Strait Islander peoples to realise opportunities through the delivery of the commitments.

Progress Since Signing


The three levels of government are already delivering for local communities throughout South East Queensland:

- 1. Accelerating jobs across SEQ
- Building high-value employment opportunities
 - Ten out of eleven Local Government members of the Council of Mayors (SEQ) have adopted the Small Business Friendly Charter, demonstrating their commitment to long-term regulatory harmonisation.
- 2. A faster, more connected SEQ Region
- Supporting the region's economic development with an integrated transport system that accommodates future growth, reduces congestion, and enhances productivity
 - Construction of the Kangaroo Point Green Bridge commenced in late 2021 and completion is expected in 2024, providing safer pedestrian and active transport connections.
 - The first phase of targeted safety upgrades along the Brisbane Valley Highway has been completed and further works are expected to begin in mid-2023.
 - Planning has commenced for the delivery of a new Brisbane Metro station at Woolloongabba to improve transport connectivity and reduce congestion.
 - Scoping of the Brisbane Metro South Bank Transport Study has commenced with the final report targeted for completion in early 2024.
- 3. A more liveable SEQ
- Enhancing the region's natural environment to support its sustainability and liveability
 - Planning for the next phase of the Resilient Rivers Initiative designed to improve management and health of SEQ rivers is underway.
 - The Blue Heart Initiative continues to support the preservation of the Maroochy River Catchment to establish wetlands to act as a flood storage area, supporting complex wetland and floodplain ecosystems to support habitat for native flora and fauna.
- 4. Creating thriving communities
- Progressing scoping for how Deal commitments will contribute to the delivery of Thriving communities in the region
 - Commencement of the Caboolture West Interim Structure Plan on 14 March 2023, providing a regulatory framework to support the assessment and approval of 13,000 new homes, across approximately half of Caboolture West.


Increased employment opportunities for Indigenous individuals and enterprises

The three levels of government recognise that the culture, history, knowledge and skills of First Nations businesses and communities are integral to the region's success. The Australian Government, Queensland Government and Local Government are engaging with First Nations communities to ensure that the partnership captures and addresses the perspectives and needs of local Aboriginal and Torres Strait Islander peoples. Strengthening our partnerships with First Nations communities aligns with the commitment of Local Government, Queensland Government and the Australian Government to Reconciliation and the National Agreement on Closing the Gap.

The three levels of government are committed to supporting economic outcomes for First Nations Australians. This will be achieved through an Indigenous employment target of 3 per cent (aligned to the Indigenous working age population of SEQ) and a 3 per cent supplier use target. Priority in meeting the targets will be given to local Indigenous businesses, organisations and potential employees. Performance against these targets will be reported as part of the reporting framework.



Accelerating future jobs for SEQ



1. SEQ Innovation Economy Fund

The Australian Government and Queensland Government will partner with the private sector and/or Local Government members of the Council of Mayors (SEQ) to invest in capital projects that promote and grow SEQ's innovation economy. Investment in the SEQ innovation ecosystem will ignite the region's nationally-significant innovation precincts to deliver more high value, knowledge-intensive jobs.

2. Smart Region Digital Plan

The Australian Government, Queensland Government and Council of Mayors (SEQ) will work together to identify the digital requirements to drive productivity and lift global competitiveness across SEQ. This Plan will:

- Identify future opportunities, connectivity gaps and digital infrastructure needs within the region
- Develop strategies to identify and prioritise areas of greater potential economic uplift from further investment in smart digital infrastructure and data technologies
- Consider opportunities to share data, embedding standard practice approaches, engagement principles and digital leadership to enhance interoperability, reduce cost of public service delivery and increase efficiency
- Support businesses and generate high-skilled jobs closer to home.

The Australian Government and Queensland Government will partner with the telecommunications industry to deliver improved digital connectivity on selected commuter rail corridors. This initiative will invest in improvements to digital connectivity along one or more selected commuter rail corridors in SEQ, reducing blackspots to assist rail commuters to maximise their productivity while in transit and stay connected to their workplace and home while commuting.

Joint activities will support Councils to fulfil their SBFC charter commitments, ensuring a consistent approach to small business matters.

6. Kangaroo Point Green Bridge

The Australian Government and Brisbane City Council will partner to deliver the Kangaroo Point Green Bridge. This new world-class landmark will create a faster and more convenient access route between the CBD, Kangaroo Point and eastern suburbs of Brisbane. The bridge will celebrate Brisbane's river city and sub-tropical identity and provide an active transport alternative, reducing congestion on the ferry, bus and road networks while improving safety outcomes and promoting a healthier community.

7. Brisbane Metro - Woolloongabba Station

The Australian Government, Queensland Government and Brisbane City Council will each invest \$150 million in a new Woolloongabba Metro station on the South East Busway (SEB) serving both Brisbane Metro and other busway services. The new station at Woolloongabba will improve connectivity between the Woolloongabba Cross River Rail station, Brisbane Metro services and bus services on the South East, supporting urban renewal across the precinct.

This will transform the Woolloongabba precinct and South Brisbane area more broadly, delivering better connectivity, transport solutions and urban realm opportunities. The project will cater for the future transport demand and needs of the region, in line with projected population growth and in preparation for the Brisbane 2032 Olympic and Paralympic Games. The Woolloongabba Station will be a key component for supporting South Brisbane as a thriving commercial hub and Games precinct.

8. Brisbane Metro - South Bank Transport Study

The Australian Government, Queensland Government and Brisbane City Council will co-fund an investigation to improve transport connectivity between the Woolloongabba and South Bank precincts and enhance pedestrian realm and place making at the Queensland Cultural Centre Busway station.

The scope of works will be informed by planning currently under consideration by the Queensland Government, Logan City Council and various capital projects committed for the area.

The upgraded infrastructure and services will improve connectivity and promote tourism to the island. The scope of the project will be informed by public consultation, including with the Quandamooka Yoolooburrabee Aboriginal Corporation.



12. Ipswich to Springfield Public Transport Corridor Options Analysis

The Australian Government, Queensland Government and Ipswich City Council will deliver a Preliminary Evaluation for a public transport corridor between Ipswich Central and Springfield Central. The commitment will include an options analysis for the connection between the Ipswich City Centre and Springfield Town Centre via the Ripley Town Centre and Redbank Plains.

13. Southern Gateway Strategic Corridor Planning

The Australian Government, Queensland Government and Logan City Council will undertake a strategic assessment of a proposed transport corridor to connect communities in Park Ridge, Flagstone and Yarrabilba with a direct link to the Logan and Gateway Motorways.

The SEQ City Deal document published in March 2022 initially considered the delivery of a business case for the Southern Gateway. The three levels of government agreed later in 2022 to rescope this commitment and its consideration of the Southern Gateway as catalyst connecting infrastructure to support investment and growth across the Southern Employment Corridor.

14. Brisbane Valley Highway Safety Upgrades

The Australian Government, Queensland Government and Council of Mayors (SEQ) will establish the SEQ Liveability Fund. The Fund will support Local Government projects that create liveable, creative, sustainable and healthy communities. Projects funded will be of a regional or sub-regional scale that leave a legacy in the community. These may include delivery of a range of improvements such as community facilities, urban amenity or enhanced liveability, and support environmental infrastructure and open spaces.



16. Resource Recovery Infrastructure

The Australian Government, Queensland Government and Local Government will develop waste processing infrastructure in SEQ that will increase resource recovery rates, facilitate organics recycling and progress the region towards a circular economy. The three levels of government will invest in a number of infrastructure projects / initiatives to support this outcome.

17. Regional Waste Management Strategy

The Australian Government, Queensland Government and the Council of Mayors (SEQ) will continue to support a region-wide approach to managing waste infrastructure to support the region's progress towards government resource recovery targets and a circular economy.

This will include opportunities to improve recovery rates of recyclable material from the general waste stream and recovering and reusing organic waste. The Australian Government, Queensland Government and the Council of Mayors (SEQ) will work together to harmonise waste management practices and policy, and align procurement guidelines to improve markets for recovered material. The three levels of government will also consider data sharing mechanisms and emerging opportunities from new recycling technologies.

This work will support implementation of the SEQ Waste Management Plan (2021) and behavioural change initiatives funded by the Queensland Government and Council of Mayors (SEQ).







25. Bromelton State Development Area Business Case

The Scheme also aims to foster synergies between industry and business activity clusters, leveraging Bromelton's proximity to the Beaudesert regional centre. The Australian Government, Queensland Government and Scenic Rim Regional Council will develop a Business Case to determine what infrastructure planning, sequencing, prioritisation and capital investment is required to activate the 15,610ha State Development Area.

The Australian Government will contribute a \$100 million loan (in-principle) to support the delivery of key trunk or next generation communications infrastructure in the development, supporting the delivery of affordable housing within the Growth Area. The Queensland Government investment will support the delivery of trunk infrastructure and the investment by the Moreton Bay Regional Council will be a proportion of the Council's overall investment in the development of the area.

27. Toowoomba Railway Parklands

The Australian Government, Queensland Government and Toowoomba Regional Council will explore options for catalysing the regeneration of the Toowoomba Railway Parklands Priority Development Area (PDA) and create an active transport corridor between the new Toowoomba Hospital – Baillie Henderson Hospital campus with the existing hospital along Gowrie Creek.

The Toowoomba Railway Parklands PDA will develop as an active, high quality, mixed density urban village which will reinforce and frame the Toowoomba CBD core area. The PDA will integrate industrial, heritage, residential choices and valuable urban parklands and contribute to amenity for the broader Toowoomba region.

The Australian Government, Queensland Government and Toowoomba Regional Council will undertake investigations and develop a business case to identify opportunities for the continued development of the Toowoomba Railway Parklands PDA, incorporating the parkland regeneration area, activating the precinct and attracting investors to deliver affordable housing.

28. Planning for Future Region-Shaping Infrastructure

The Australian Government, Queensland Government and Local Government are considering an approach for infrastructure in SEQ to support a more vibrant and connected region and enable better access to jobs, services and recreation.

Developing a plan for Future Region Shaping Infrastructure will consider both infrastructure and land use planning to enable more informed investment by both governments and industry in SEQ, securing better value for money. The three levels of Government will work together to develop a mechanism of consultation and cooperation to consider population growth; housing accessibility; reducing congestion; enhancing transport connectivity, building efficient freight networks, enhancing enabling digital infrastructure and increasing road safety.

This commitment will incorporate a consideration of regional freight movements, key priority freight corridors (including but not limited to the Mount Lindesay Highway) and priorities for future infrastructure investment to enhance supply chain logistics in the region. The Queensland Government will also consider an agreed approach with Local Government and Queensland Rail for upgrading level crossings in SEQ to enable better transport and freight mobility in SEQ.

Governance and Implementation Framework

The partnership aims to drive genuine trilateral governance reform, with all three levels of government working collaboratively to deliver the partnership's objectives and commitments. The partnership will establish and maintain trilateral governance arrangements that provide multiple forums for the three levels of government to implement the commitments while responding to emerging issues in the region and evaluating future opportunities.

The Australian Government will provide funding under the Federation Funding Agreement – Infrastructure and the National Partnership Agreement on Land Transport Infrastructure Projects. The Queensland Government will enter into contractual arrangements with relevant Local Governments or private operators, as appropriate, for delivery of agreed infrastructure. The Queensland Government will provide reports to the Australian Government on progress of the commitment under the arrangements of the Federation Funding Agreement – Infrastructure and the National Partnership Agreement on Land Transport Infrastructure Projects.
